WAIVER OF LIABILITY FOR MEDIA REPRESENTATIVES

CONSENT AND LIABILITY RELEASE AND INDEMNIFICATION AGREEMENT

- 1) I am aware of the inherent risks and dangers associated with motor sport events and undertake to follow all instructions given by the organisers, race control, the marshals, security personnel or law enforcement officers and their representatives (in written, verbal or visual form) promptly and, in particular, to not enter restricted areas of safety zones.
- 2) I accept that I am acting at my own risk when leaving the area generally accessible for spectators and the areas explicitly designated by the race control – even if staying there is allowed by the organiser. The areas explicitly designated by race control are: All the areas designated as spectator areas, the entire paddock and service area including all the connecting roads and through roads, the pit area
- 3) I am aware that staying in front of track boundaries, such as crash barriers or concrete elements, in restricted areas of safety zones and obvious danger zones is strictly prohibited.
- 4) I declare with the cession of this media representatives' declaration that I waive the right for all kinds of damages which are linked to the event, namely against:
 - Fédération Internationale de l'Automobile (FIA) and its representatives
 - The organisers, their representatives, marshals and volunteers, racetrack operators
 - The circuit owners and their representatives.
 - The competitors, drivers, passengers/vehicle keepers, vehicle owners and their helpers
 - Public authorities, racing services and other persons or institutions or institutions connected with the event's organisation.
- 5) The disclaimer does not apply for damages or harm to life, body or health or any other damage resulting from the deliberate or gross negligent breach of duty, and not for any damage resulting from the breach of a material contractual obligation committed by the group of persons released from liability. In the case of damages resulting from a slightly negligent breach of duty of a material contractual obligation, the liability for financial loss and for damage to property is limited to the typical foreseeable damage. The disclaimer applies to claims for any legal reason whatsoever, so in particular to claims for damages based on contractual and non-contractual-liability and to claims from tortuous acts. Implied exclusions from liability shall remain unaffected by the above non-liability clause.4. The areas explicitly designated by the race control for the media coverage are marked on the track map. I will study this map on every day of the event and will respect it.
- 6) I am aware that the use of TV and video cameras has to be sanctioned in written form by the owner and administrator of the film and TV rights. The owner and administrator of the film and TV rights reserve the right to take legal action in the case of an illegal use of TV and video cameras. Any filming permit must be requested from the FIA.
- 7) I have been made aware that a breach of the aforementioned paragraph results in the revocation of my media accreditation and can result in legal consequences. The disclaimer will take effect with the cession for all involved parties.
- 8) I will attend any physical Tabard Media Safety Briefing scheduled at each event. I will also read any safety-related documentation issued.
- 9) I understand the issuing of my media tabard is subject me attending any physical Tabard Media Safety Briefing scheduled at each event or reading any safety-related documentation issued.
- 10) I understand I will pay a deposit for my media tabard, which I will return within 30 minutes of the final race of an event.
- 11) I accept that my all-season media pass remains the property of the FIA at all times and can be withdrawn without notice.
- 12) I acknowledge that my all-season media pass is strictly non-transferrable.
- 13) In the event of my all-season media pass becoming lost I will inform the FIA's ETRC media representative immediately.
- 14) I understand and accept that there are two types of all-season media pass. One provides access to the paddock and media centre. The other provides access to the paddock, media centre, designated trackside photo points, pit lane and grid when wearing a valid media tabard and following all safety instructions.
- 15) I accept that at some/all venues I will be required photographers/videographers/camera operators to present proof of valid professional indemnity insurance or similar before I am issued with a media tabard.
